ALL applicants will receive an email in the CVCC email account regarding final status in the program after the June 15, 2021 Minimum Admissions Requirement (MAR) deadline. Documents must be emailed to healthcare@cvcc.edu; documents delivered in any other way are not accepted.

Applicants must ensure all materials have been submitted to healthcare@cvcc.edu before the deadline and as directed by the Admissions Packet. NOTE: **Applicants to the LPN-RN Bridge must have a current, unrestricted North Carolina Practical Nurse license.**

- 1. **DO THIS STEP FIRST: Activate the [CVCC Application](#) with “LPN-RN Bridge Nursing” as intended major with appropriate entry term.**

*Applications are **activated** when an applicant sends an email to admissions@cvcc.edu with a request to activate the application and a cell phone photo of a valid photo ID (Driver's License). Previous students must have an active program status to be considered for the program; email healthcare@cvcc.edu to inquire about active program status. *Applicants are responsible for reading and understanding LPN-RN Admissions Packet contents and meeting requirements.*

- 2. Submit official [High School/High School Equivalency Transcript](#) in a sealed envelope issued from the school, electronically through a 3rd party vendor to transcripts@cvcc.edu or by postal mail. Plan accordingly to ensure transcripts arrive by the deadline.
- 3. Submit official sealed [College Transcripts](#) from EVERY school EVER attended (except CVCC) in a sealed envelope issued from the school, electronically through a 3rd party vendor to transcripts@cvcc.edu or by postal mail. Plan accordingly to ensure transcripts arrive by the deadline. If additional coursework is completed after submission of transcripts, an official *updated* transcript must be submitted to CVCC to ensure transfer credit.
- 4. Submit official LPN transcript and Employment Verification Form (EVF) to document work experience.
- 5. Complete required courses (BIO 168, BIO 169, ENG 111, PSY 150) with a grade of “C” or higher in each course.
- 6. Submit a copy of a current, unrestricted [North Carolina](#) Practical Nurse license.
- 7. Meet college **GPA** Requirement of 2.00.
- 8. Attend Mandatory Information Session (Dates and times are published on the nursing webpage.)

- 9. Take the **ATI NCLEX-PN Comprehensive Exam**. Official scores sent from other locations must come through [ATI Testing](http://www.atitesting.com) (www.atitesting.com) and must be received at CVCC by the deadline date. Test must be taken between June 15, 2020 and June 15, 2021.
- 10. **Submit the completed MAR Checklist before the deadline.** From the student's CVCC email account, send a scanned or cell phone photo of the completed MAR Checklist to healthcare@cvcc.edu. The *entire* document must be legible and readable.
